

Minutes of the 23rd Executive Committee Meeting of State Health Society, Assam held on 18th July, 2021

The 23rd Executive Committee (EC) Meeting of State Health Society, Assam was held on 18th July 2021 in the NHM Conference Hall at 4-00 PM under the Chairmanship of Shri Anurag Goel, IAS, Principal Secretary to the Govt. of Assam, Health & FW Department.

Record of proceeding of the meeting:

- 1. At the outset, the Mission Director, NHM welcomed all the members of the meeting. Subsequently MD NHM made an agenda wise power-point presentation (Annexure II) for detailed discussion by all members. After threadbare discussion on the agenda items, the following resolutions were adopted:
- 2. Action Taken Report of 22nd EC meeting:The Chairperson, EC confirmed the minutes of the 22nd EC meeting and noted action taken reports.
- 3. Approval of Draft Emergency COVID Response Plan-II, FY 2021-22:-

After threadbare discussion, the EC approved an amount of **Rs. 771.22 Crs** under Emergency Covid Response Plan-II (ECRP-II), FY 2021-22 (At Annexure III) to place before the Governing Body meeting for approval and onward submission to the Govt. of India.

The Mission Director, NHM informed that list of health facilities prepared for ECRP-II for upgradation, especially for the Prefab facility with 6 beds, are based on desk work only and subsequent modifications may be required as per ground level situation. The modified final list will be placed before the EC/GB for approval in respect of establishment of additional beds provisions at SC, PHC & CHC and Spokes of Tele-Consultation. The EC meeting approved the proposal with the above mentioned rider.

4. Approval of REQUEST FOR PROPOSAL (RFP) for selection of banking partner in order to open Single Bank Accounts:-

The EC approved for floating of REQUEST FOR PROPOSAL (RFP) for selection of banking partner in order to open a Single Bank Accounts of NHM as per Gol guideline.

5. Extension of Command & Control Centre with NIC Guidance:-

The EC approved the proposal for extension of agreement with M/s eCentric Solutions Private Limited for Command & Control Centre under guidance of NIC for another one (1) year w.e.f 20th July'21, subject to approval of the GB.

6. Health HR Plan:

The EC noted the Health HR Plan under NHM and approved the proposed recruitment against 996 vacant posts including technical and non technical staffs and recommended the proposal to the GB.

The EC approved re-demarcation of the Health Blocks in the newly created Districts, with necessary appraisal and approval of the GB. In this context, the EC entrusted Mission Director, NHM to seek proposal from the respective Jt. DHS of the concerned districts regarding the re-assignment of health institutions in newly divided districts and submit to the Govt.

7. TA/DA of NHM Employees:

The Chairperson, EC suggested revised TA/DA proposal of NHM employees to be moved in file along with comparative analysis with existing Govt of Assam rates and proper justification.

The meeting ended with vote of thanks from the Chair.
