MINUTES OF THE MEETING OF THE 25TH EXECUTIVE COMMITTEE MEETING OF STATE HEALTH SOCIETY OF NATIONAL HEALTH MISSION (NHM) HELD ON 22ND MARCH 2023

The 25th Executive Committee meeting of the State Health Society of National Health Mission, Assam was held on 22nd March 2023 at 3:30 PM at the NHM Conference Hall under the Chairmanship of Shri Avinash Joshi, IAS, Principal Secretary to the Government of Assam, Health & Family Welfare Department.

At the outset, the Chairperson of the committee welcomed all members of the committee.

Dr. M. S. Lakshmi Priya, IAS, Mission Director, National Health Mission, Assam made a brief presentation. Copy of the presentation is Annexed as Annexure – II.

Record of proceedings of the meeting:

1. The Chairperson of the committee suggested to move file for modification of the frequency of the Executive Committee meeting from 1 month to 3 months. Chairman also directed to ensure conducting EC meetings in every 3 months.

Action by: SPM, Consultant Planning, NHM

 Action taken report on the decision point of 24th EC meeting regarding strengthening referral mechanism from the remote villages was discussed in the meeting. MD NHM informed that, steps have been initiated to strengthen the referral mechanism mainly in the hard to reach areas. In district RoP 2022-23 under JSSK- referral transport, districts with difficult areas have been provided additional fund to cover those areas by managing locally.

The Chairperson of the committee opined that, to provide referral transport services to the patients is the responsibility of Health & Family Welfare Department to save lives. However, M/s EMRI Green Healthcare Services has been entrusted to provide Mrityunjoy 108 services and supposed to cover all areas of the State.

Following decisions were made in the meeting:

a) Reimbursement of referral transport fund under JSSK may be continued to patients of hard to reach areas where 108 services could not be provided.

b) However, the amount should be recovered from the monthly bill of M/s EMRI Green Healthcare Services for the amount reimbursed to the patients of accessible areas covered by 108 services.

3. Action taken report on the decision point of 24th EC meeting regarding orientation of the legislative forum on HIV-AIDS, Tuberculosis and Tobacco Control program was discussed in the meeting. MD NHM informed that, orientation programme was scheduled on 19th June 2022, but could not be completed conducted due to flood in the month of June 2022 as per communication received from Additional Secretary, ALA.

Following decisions were made in the meeting:

- Orientation of the legislative forum on HIV-AIDS, Tuberculosis and Tobacco Control program should be arranged within the ongoing budget session.
- b) Officer on Special Duty, NHM, Assam will coordinate with the head of the program division of HIV-AIDS, Tuberculosis and Tobacco Control program so that in one session of the legislative forum, Hon'ble members of the Assam Assembly can be oriented on all these three programs during the ongoing budget session.

4. Action taken report on the decision point of 24th EC meeting regarding Component wise review of each program by the concerned division was discussed in the meeting. MD NHM informed that, performance of programmes are reviewed with districts and blocks on regular basis including in the Swasthya Manthan and regional review meetings.

The Chairperson of the committee opined that, Swasthya Manthan cannot be replacement of the division wise review and division wise review should be ensured.

Following decisions were made in the meeting:

a) Division wise review of all component should be ensured on quarterly basis.

 Action taken report on the decision point of 24th EC meeting regarding appointment of HR was discussed in the meeting.

a) All appointments of vacant posts under NHM should be completed within 6 months.

6. Action taken report on the decision point of 24th EC meeting regarding 100 bedded hospital block at Suwalkuchi was discussed in the meeting.

Following decisions were taken in the meeting:

 a) DPR of 100 bedded hospital block at Suwalkuchi should be completed within April 2023.

7. Action taken report on the decision point of 24th EC meeting regarding revision of initial pay of Specialist Doctors to Rs. 75,000/- per month from existing Rs. 65,000/- per month w.e.f. 01.04.2022 and differential remuneration / location based incentive for hard to reach areas/health institutions for specialist cadre was discussed in the meeting.

Following decisions were taken in the meeting:

- a) As per decision taken in the 24th EC meeting, revision of initial pay of Specialist Doctors from existing Rs. 65,000/-to Rs. 75,000/- per month should be processed immediately.
- b) A committee should be constituted to identify hard to reach areas for differential remuneration/location based incentive for specialist cadre. Recommendation of the committee should be put up to the Principal Secretary, Health & Family Welfare Department within 1 month.

Action by: ED, NHM and HRD Consultant, NHM

8. Action taken report on the decision point of 24th EC meeting regarding up gradation of existing Blood Bank at Sibsagar Civil Hospital, Sivasagar was discussed in the meeting. MD NHM informed that, the work has been taken up under CSR fund.

Following decisions were taken in the meeting:

- a) Consultant (Maternal Health), NHM should confirm the progress of blood bank at Sibsagar Civil Hospital, Sivasagar under CSRfund and submit the report within 1 week.
- b) If the work is not yet started then, Project Director, Assam State AIDS Control Society will take up the matter to upgrade the existingBlood Bank at Sibsagar Civil Hospital, Sivasagar from ASCAS fund.

9. Action taken report on the decision point of 24th EC meeting regarding implementation of e-Hospital software in additional health facilities under ECRP-II was discussed in the meeting. It was informed that, procurement of IT hardware already completed and taken up with NIC for configuration and training of e-Hospital application.

Following decisions were taken in the meeting:

 e-Hospital application should be started in the 7 hospitals (excluding CN Centre, GMCH) within 2 months with the help of NIC.

Action by: Manager-MIS, NHM

10. The Executive Committee discussed the draft proposal under PM-ABHIM for the FY 2023-24 and recommended the proposal amounting to Rs. 662.33 Cores for different components. Further, the EC recommended an amount of 4.52 Crores for PM cost fund under PM-ABHIM. The proposal should be placed before the next Governing Body meeting of State Health Society, Assam for kind perusal and post facto approval.

11. The Executive Committee discussed the proposals under 15th Finance Commission Health Grant forthe FY 2023-24 amounting to Rs. 240.58 Cores. The proposal has already been placed before State Level Committee (SLC), XV-FC (Health Grant) held on 18th March 2023. The proposal may be placed before the next Governing Body meeting of State Health Society, Assam for kind perusal.
