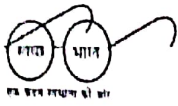



The meeting ended with vote of thanks from the chair.


