Minutes of District Indemnity Sub-committee (DISC) Meeting

District Indemnity Sub-Committee (DISC), Goalpara Meeting held on 16th July 2021 at the conference hall of Deputy Commissioner Office under the chairmanship of Joint Director DHS Goalpara and Additional Chief Medical and Health Officer (FW), Superintendent of Goalpara Civil Hospital, Deputy Superintendent of Lakhipur BPHC and Dudhnoi FRU, All SDM& HO of all BPHC, One Empanelled Laparoscopic Surgeon, One Empanelled NSV Surgeon and other three members from DISC. After discussion of different issues of family planning services and review of the last meeting action taken report following resolution are taken.

Resolution I.

In connection of World Population Day and Fortnight 2021 beneficiaries duelist need to be prepared at block level and cover all due listed beneficiaries by FDS and FDSS of different family planning services. Detail services delivery plan need to be prepare for cover all beneficiaries as per need.

Action taken by: BPM, BCM, BDM at BPHC level for duelist preparation, DFPC will monitor the service delivery sites according to the due list.

Resolution II.

As per direction of Joint Director and Addl.CM & HO (FW) the Interval IUCD performance need to be increase, they had instructed to all the ANM's to insert one Interval IUCD per 1000 population in general besides other method.

Action Taken by: SDM&HO All BPHC, Incharge All PHC has review the performance at Block review meeting per month.

Resolution II.

The PPIUCD performance should be minimum 40% against the total institutional delivery.

Action Taken by: SDM&HO All BPHC, Incharge All PHC has review the performance at Block review meeting per month.

Resolution III.

The PAIUCD performance should be 100% against each abortion cases and during the act 'MCP Card' and presence of ASHA is the most.

Action Taken by: SDM&HO All BPHC, Incharge All PHC has review the performance at Block review meeting per month.

Resolution III.

As per direction of ADC (Health) Goalpara, the issues of illegal MTP services need to be stop at early as possible. ADC (Health) Viewed seriously and statutory warning is given by him for illegal abortion outside the Medical Institutions.

Action taken by: SDM&HO, All BPHC and Incharges of all respective PHC, review the matter and report to ADC (Health) Goalpara .

Additional Chief Medical & Health Officer (FW) Goalpara and Selected DISC member will visit all FDS services site along with SDM&HO of respective service delivery sites.

Documentation and registers related to the Family Services as well as others need to maintain properly by all Health Institution and routine monitoring needed in every level.


Action taken by: DFPC/DPM/DDM, BPM/BCM / BDM/ BAM of respective BPHC
