 - **DFPC shared PPT on WPDF and discussed he two parts of the program**
 1. **Mobilization Fortnight (Dampatti Sampark Pakhya):** to be observed from **27th June to 10th July 2023**. This fortnight is meant for mobilizing eligible clients through extensive IEC and awareness activities and to generate demand for family planning services which will be met subsequently during population stabilization fortnight by service providers.
 2. **Population Stabilization Fortnight/Services Delivery Fortnight/(Janasankhya Sthirata Pakhya):**to be observed from **11th –30th July 2023**

Activities under Sub cener-
Saas Bahu sammilan at HWC-

 - ‘Saas Bahu Sammelan’ means “A Coming Together of Mother and Daughter-in-Law’.
 - The community event focuses on acceptance of family planning method in the family. Freely discuss about women’s health, hygiene etc.
 - Participants are newly married women, pregnant and lactating women with their mothers-in-law.

The DFPC shared the BPHC wise target to achieve the WPDF target for the year.

The Addl CM&HO advised all members present there to make the program a successful one.

The SDM&HO all BPHC shared concern regarding achievement of WPDF performance due to current flood situation in the district.

The JT DHS expressed that due to lack of empanelled O&G Specialist and surgeon the Laparoscopic sterilization (FDS) camps are not conducting in the district. Therefore the JT DHS urged the authorities from LMCH to depute Specialist for conducting camps at BPHC.
