During this meeting following points were discussed and taken the resolution.

1. Joint Director of Health Services, Darrang welcomed all the present Officials and Members of District Indemnity Sub committee and discussed briefly the objective of the meeting.
2. DFPC, NHM, Darrang bring to knowledge of the house about the performance of Family Planning (April to July 2023).
3. DPM, NHM, Darrang requested to the DISC members to monitor the LS, NSV, IUCD Fixed Day Services & Fixed Day Static Services in routinely, so that gap may be closed in Family Planning activities. Action- DISC members.
4. The House decided to restart the LS fixed day services at Deomorno CHC and Kuwaripukhuri Model Hospital. Action- Addl. CM&HO and DFPC.
5. Every month atleast 2 nos LS FDS should be conducted at Kharupetia CHC covering all Health Institutions of Kharupetia BPHC. Action- SDM&HO and BPM of Kharupetia BPHC.
6. NSV performance should be increased, in this regard awareness meeting to be organized at Tea Garden area, Char area etc. Action- DFPC.
7. Antara camp should be arranged rotinly at Sub Centre level so that performance can be increased. Action- Block SDM&HO, BPM and BCM.
