- The objective of the meeting was shared by Mr. Chaitanya Bora, DFPC, Lakhimpur. The purpose of the meeting was to discuss about the performance of family planning fortnight 2023 and meeting the gape of Laparoscopic service in the district.
- The Jt. DHS expressed that due to lack of empanelled O&G Specialist and surgeon the Laparoscopic sterilization (FDS) camps are not happening in the district. Therefore the JT DHS urged the authorities from LMCH to depute Specialist for conducting camps at BPHC.
- The DFPC shared the BPHC wise target to achieve the family planning target for the year.
- The Addl. CM&HO advised all members present there to make the family planning program a successful one.
- Jt. DHS urged Dr. Moon Konwar to practice laparoscopic sterilization at LMCH to boost up his confidence.
- Jt. DHS urged Dr. Prabin Mili to provide laparoscopic sterilization service at different health institution when required. He was also requested to render NSV services at BPHCs.
- Jt. DHS shared that he will take few times to conduct Laparoscopic sterilization camp at BPHCs and he will request Dr Gubin Saikia, proprietor of Royal Treat Hospital, a private practitioner as he was previously a govt. empanelled laparoscopic service provider.


The meeting ends with a vote of thanks from Jt. Director of Health services, Lakhimpur.
