**Minutes of the District Indemnity Sub- Committee (DISC) Meeting**

A meeting was convened for District Indemnity Sub-Committee (DISC) under the chairmanship of Dr. Jayanta Bhattacharjee, Joint Director of Health services, Tinsukia on 26<sup>th</sup> October 2023 at 2.00 PM in the office chamber of Jt. The meeting was chaired by Dr. Jayanta Bhattacharjee, Joint Director of Health services, Tinsukia. The following points were discussed during these meeting.

- Joint Director of Health services, Tinsukia in his inaugural speech gave a brief and concrete overview of activities of District Quality Assurance Committee (DQAC) and Dist Family Planning Sub-Committee (DISC).
- Joint Director of Health services, Tinsukia in his inaugural speech gave emphasis on DQAC checklist to be followed viz. Annexure – 6 for Facility Audit, and Annexure -19 for client exit interview.
- A resolutions was taken for next FY – 2023-24 that 5 percent of DQAC members will visit fixed day services and fixed day static site once in a month.
- Joint Director of Health services, Tinsukia entrusted DCQA along with quality team for Facility Audit of empanelled Govt. Hospitals where FDS & FDSS are given for quality services and approved the proposal for newly identified Pvt. Hospitals, (i) Panitola TE Hospital (ii) Beesakopie Central Hospital with due facility audit report for feasibility.
- Updating of Empanelment of all family planning service delivery categories wise done by the Joint Director of Health services, Tinsukia and accordingly a notification will be issued.

- Regarding reorganization of Tinsukia into MPV Dist Jt. DHS has emphasized all the FP methods, temporary as well as permanent to be extended in <sup>to</sup> the grass root level of the community.
- It has been observed that the performance of temporary methods under Tinsukia District is not up to the mark, especially in terms of IUCD, PAIUCD and Injectbale Antara. So Jt. DHS, Tinsukia urged all the members, who were present in the meeting to uplift the temporary methods during community visit.
- Jt. DHS urged all to promote Inj. Antra (DMPA) in Tinsukia Civil Hospital as well as the PHC, CHC levels and accordingly suggested to rollout the service <sup>of</sup> Inj. Contraceptive to SC level.
- Jt. DHS suggest <sup>to</sup> DDM to find out the name of ANM & GNM who already <sup>have</sup> been trained for integrated IUCD and not performing the same.
- DFPC has also updated the performances done during World Population Day (WPD) fortnight and is happy to inform the committee that Tinsukia Dist has achieved the ELA (Expected Level of Achievement) up to the mark as per State requirement.
- The meeting ended with vote of thanks from the chair.
