With reference to the subject cited above I would like to inform you that Mina Das , W/o- Ranjit Das , Village- Kaoimari , P.O- Rampur Dekapara , P.S – Sarthebari , Barpeta underwent Laparoscopic Sterilization on 28th July , 2017 at Pathsala SDCH . After sterilization she developed complication and admitted at Pathsala SDCH on 29th July , 2017 and she was referred to FAAMC &H , Barpeta on the same day. Due to the sever complication she was again referred to GMCH on 31th July 2017. Unfortunately she died on 31th July , 2017 at 4 p.m.

As per guideline compensation amount of Rs 200000/- is eligible to the deceased family under Section-I. The DISC (District Indemnity Sub Committee) approved Rs 200000/- as companion money to the deceased family in the meeting held on the 7th August 2017.
