Minutes of District Level District Indemnity Sub Committee (DISC) Meeting

The District level DISC meeting for 3rd quarter (FY: 2017-18) was held on 9/1/2018 at the office chamber of Joint Director of Health services, Barpeta. The meeting was presided over by Joint Director of Health services, Barpeta where Addl. CM&HO (FW), Barpeta & SDM&HO, Kalgachia BPHC (Empaneled NSV Surgeon) were present in the meeting.

The following points were discussed and passed the resolutions at the meeting:

- ❖ As per Empaneled LS Surgeon Dr. Paresh Kalita, SDM&HO(Epidemic), equipments for LS operation are too old to use properly at the LS camps. So, as per his concern, it's a huge lack for smooth operation of LS camps in the district. Hence, the DISC came to the point that there is an urgent need for LS service operative machine for smooth delivery of Service. Therefore District level DISC will request to the state for urgent supply of LS machine for the said reason.
- ❖ As of now, there is no existing machine for LS operation at Sub-Divisional Civil Hospital, Pathsala. Therefore, the facility could not start fixed Day static services till now. So, the District level DISC came to the point that, DISC will request to the concerned higher authority to supply LS operative machine to the facility so that FDS services can be started as early as possible.
- ❖ As per Dr. Paresh Kalita (empaneled LS Surgeon), who is the only empaneled surgeon in the district and his suggestion was that there should be more trained empaneled Surgeon needed for the LS services at various level.
- ❖ At District level DISC meeting, the Joint Director of health services discussed and passed the resolution for maintaining Quality of services during the LS camps and at the FDS Service sites. There should not be any compromise over the quality of services.
- ❖ The District Indemnity Sub-Committee discussed and passed the resolution for proper counseling for Family Planning services to be given to every single client at the time of LS operations at camps and FDSS sites.
- ❖ The District Indemnity Sub-Committee also discussed about the consent of the clients to be taken as per prescribed format without any lapse, as Consent is the most important part of the services.
- ❖ The District Indemnity Sub-Committee noticed that there was no death has occurred in 3rd quarter during the time of LS operations and NSV operations.
