A District Family Planning Indemnity Subcommittee meeting was held on 13th March'2018 at 11:30 AM onwards at District Training Center of DFWB, Darrang, Mangaldai under the chairmanship of Jt. DHS Cum Member Secretary, DHS, Darrang.

The Jt. DHS Cum Member Secretary District Health Society, NHM, Darrang chaired the meeting in presence of Addl. CM&HO, (FW) cum Jt. Secretary, DHS, Darrang, Superintendent of Mangaldai Civil Hospital, Empanelled LS Surgeon & NSV Surgeon, DEMO & Dy. DEMO of DFWB, Darrang, DPM, DFPC and District Consultant Quality Assurance, NHM, Darrang. As per agenda various issues of family planning services and claims of sterilization cases were discussed in details.

During this meeting following points were discussed:

1. Joint Director of Health Service cum member Secretary, DHS, Darrang, gave a brief of objective of the meeting.
2. Addl. CM&HO reviewed the last cases that was approved by Deputy Commissioner, DHS, Darrang with the compensation provided to them. He also reviewed the progress of family planning services.
3. District Consultant Quality Assurance briefly discussed the importance of cleanliness and Quality services in family planning services. Regarding this an order letter has been issued already to form Quality Improvement Team in Health institutions. She also updated the QIT formed in Health Institutions.
4. Claims were presented by Dy.DEMO. A total of 5 laparoscopy failure cases were discussed with all verifying documents and it was reviewed by all members of District Family planning indemnity subcommittee.
