- Application of any claim, from the acceptor of sterilization should forwarded by the concerning i/c of the Health Institutions after proper verification of required documents
- 2. Documents required for failure of sterilization:-
  - (a) Claim form cum Medical Certificate in original duly signed.
  - (b) Copy of Consent form duly attested.
  - (e) Copy of Sterilization Certificate duly attested.
  - (d) Copy of any of the following Diagnostic Reports confirming failure of sterifization duly attested.
    - Urine test report supported by physical examination report /AN Card / USG Report.
    - · MTP Report.
    - > Physical examination Report.
    - USG Report.
    - In extreme cases birth certificate in case of full term pregnancy.
