This is to inform you that vide letter no. referred at serial No. 3, above Tablet Methyl Ergometrine I.P 0.125 mg, Tablet Doxylamine Succinate 10 mg, Tablet Acyclovir 400 mg & Tablet Diclofenac Sodium IP 50 mg against awarded supply orders were found "Not of Standard Quality" against the analytical test reports from Regional Drug Testing Lab for below mentioned batch nos.:

- 1. Tab Methyl Ergometrine I.P 0.125 mg, Batch No: TMEG-019 & TMEG-021.
- 2. Tab Doxylamine Succinate 10 mg, Batch No: TDXY-005 & TDXY-002.
- 3. Tab Acyclovir 400 mg, Batch No: TPVR-008 & TPVR-011.
- 4. Tab Diclofenac Sodium IP 50 mg, Batch No: TDC5-024.

In spite of several show cause notices issued by NHM, Assam referred at serial No. 3 to your firm, you have failed to furnish satisfactory replies within prescribed time frame.

Hence in the interest of public service, you are hereby disqualified to participate in any tender of NHM / Govt. of Assam for a period of 5 years from the date of issue of this letter. In this context you are also hereby directed to withdraw all the unconsumed batches of drugs within 1 month from the districts as well as medical college drug store or subsequent penal action as per tender clause will also be incorporated against your firm.
