
Apart from reconstitution of the committee, the following points were also discussed critically and decisions being taken:

1. Due to non functioning of **DQAC(District Quality Assurance Committee)**, Dhemaji from last few months a new committee is reconstituted under the Chairmanship of the Deputy Commissioner, Dhemaji
2. It is decided, the DQAC(District Quality Assurance Committee) will have quarterly and the action calendar also be prepared for visiting the Health Institutions as per the functional guidelines of DQAC.
3. The BPHCs/CHCs/FRUs organizing LS camps in their hospitals will have to register cases along with pre-operative preparation viz, checking pulse, BP, Hemoglobin, Blood sugar (random) and Urine for sugar and protein and also systematic examination including pregnancy test. After screening the beneficiaries names are to be registered.
4. Due to unavailability of Boyles apparatus and non functioning of Surgical Instrument & Laparoscopic Machine at Dhemaji Civil hospital, the Superintendent will prepare drafts letter and the Deputy

Commissioner, Dhemaji will recommend the same to MD, NHM, Assam for obtain the requirement.


5. The DQAC member will visit both private/public facilities periodically where Family Planning services are rendered.
6. Committee will direct & ensure measures for increasing the quality of sterilization. The gauze and other surgical material are to be perfectly sterilized prior to the camp.
