This is to inform you that with reference to the above purchase order (referred at pt. 1) NHM, Assam have awarded your firm to supply Tab Albendazole 400 mg (chewable) for **NDD 2018 August round** ( a Govt. of India pre-scheduled programme on deworming) against your written declaration (referred at above at pt. 2) that your firm will be able to supply 80 lakhs Albendazole Tab within 31<sup>st</sup> July 2018.

Whereas, you didn't complete the supply with in stipulated time directly affecting Govt. of India programme-National De-worming Day-August round 2018 which have started from 10<sup>th</sup> August state could not implement the deworming in all the districts depriving Public health service in the state of Assam.

Several reminders were mailed to you and even show cause notice was also served to your firm as per letter referred above at pt. 3, but you did not even reply to this show cause notice which reflects your absolute negligence towards patient health.

Hence, as per the contractual obligations and penalty clause for delayed delivery, your firm i.e Kniss Laboratories Pvt. Ltd is hereby disqualified to participate in any tender in the state of Assam for a period of 5 years from the date of issuing the letter.

You will also forfeit your security deposit which was submitted with the tender as per above mentioned tender norms.
