Sir/Madam,

This is to inform you that above purchase orders for supply of essential drugs had awarded to your firm, whereas you are yet to commence the supply. You have failed to supply the drugs in spite of multiple reminders causing delay of more than 8 months. It is directly affecting patient's community, attending Govt. health facilities of the state of Assam. Your failure to complete the supply within contractual date of delivery is hampering the patient benefit of 'NHM Free Drug Services', the scheme of Govt. of India. So in public interest and as per contractual allegation, you are hereby disqualified to participate in any Tender of NHM, Assam for a period of 5 years from the date of issuing the letter as per above referred tender clause no. 17 "supply condition" pt. no. "E" "penalty for delayed delivery".

As you have submitted a proposal to the NHM, Assam vide refer 3 above that you are now ready to supply the ordered consignment, as a one time exception you are allowed to complete the supply of total ordered quantity within 10 working days without any further delay. It is also to be noted that prior to commencement of supply you have to submit the agreement, performance security and NABL Test report to get the dispatch clearance certificate.
