#### **Proceedings:**

The meeting started with a welcome address by Dr. N.M. Das, Joint Director of District Health Society, Goalpara and Mr. Khorshed Alom, Dist. Programme Manager, National Health Mission presided over the meeting.

### Key points that emerged from the meeting:

- Dr. N.M. Das, Joint Director of District Health Society, Goalpara in his inaugural speech gave an overview of District Quality Assurance Committee and District Indemnity Sub Committee. He pointed out that though there is no issue of serious on Family planning Programmes in the District but at the same time he felt that more work is required to be done to fulfill the objective of different programmes runned under Family Planning Cell in the District.
- On his speech he appealed to all that after operation if complication and failure may occur guide the beneficiary well and gives their rights through the family planning indemnity scheme (FPIS).
- Joint Director of Health services, Goalpara said that it is to be ensured that the facility
  has adequate circulation area and open spaces according to need and have adequate
  space as per patient or work load.
- Again he stressed that where the sterilization going on is maintained appropriately and patient care areas are clean and hygienic.
- It is to be ensured that in critical areas of the facility ensures availability of oxygen in times of emergency.
