The meeting started with a welcome address by Dr. R. Basumatary , Joint Director of District Health Society, Goalpara and Ms. Nandini Das, Dist. Family Planning Coordinator, National Health Mission presided over the meeting.

Key points that emerged from the meeting:


1. Dr. R. Basumatary , Joint Director of District Health Society, Goalpara in his inaugural speech gave an overview of District Indemnity Sub Committee. He pointed out the Family Planning Performances during 1st quarter (April, May, June) 2017 and discussed about the low performing Health Institution.
2. Dr. Bhanu Saikia, Addl. Chief Medical & Health Officer (FW), Goalpara, stated that most of the ANM didn't maintain the RCH register. So that they didn't identify the Eligible Couple in proper way and this is also hampers on different family planning services.
3. Dr. R. Basumatary Joint Director of District Health Society, Goalpara on his speech he appealed to all that after operation if complication and failure may happen then all responsible officer should be guide the beneficiary well and gives their rights throughout the family planning indemnity scheme (FPIS).
4. Dr. Bhanu Saikia , Addl. Chief Medical & Health Officer (FW), Goalpara, instructed all that during Laparoscopic & NSV Camp people should be follow the guidelines and ensured that where the sterilization going on is maintained appropriately and patient care areas are clean and hygienic.

5. Dr. R. Basumatary Joint Director of District Health Society, Goalpara instructed to all that to ensure about the drugs, dropping facility, availability of oxygen in times of emergency before camp and facility ensures adequate power backup in all patient care areas as per load .
6. Dr. MK Choudhury stated that the PPS services are functional in Goalpara Civil Hospital only that is why the Female Sterilization ratio is not so high.
7. Dr. R. Basumatary Joint Director of District Health Society, Goalpara said that all failure, complication and death cases (if happen) will reviewed in quarterly basis under District Family Planning Indemnity Subcommittee and instructed to all SDM&HO,BPM's & ABPM,s to review all cases and performances in their monthly meeting and send the cases in proper format along with all necessary documents to Additional Chief Medical & Health Officer (FW) Goalpara.
