Proceedings:

The meeting started with a welcome address by Dr. N.M. Das, Joint Director of District Health Society, Goalpara and Mr. Khorshed Alom, Dist. Programme Manager, National Health Mission presided over the meeting.

Key points that emerged from the meeting:


1. Dr. N.M. Das, Joint Director of District Health Society, Goalpara in his inaugural speech gave an overview of District Quality Assurance Committee and District Family Planning Indemnity Sub Committee. He pointed out that though there is no issue of serious on Family planning Programmes in the District but at the same time he felt that more work is required to be done to fulfill the objective of different programmes runned under Family Planning Cell in the District.
2. Dr. Bhanu Saikia, Addl. Chief Medical & Health Officer (FW), Goalpara, stated that the District Quality Assurance Committee newly notified so the orientation meeting on DQAC was organized for the concerned people and all Block level employees to discuss about the quality, blockage and the responsibilities of each Members of the Committee and the block level people.

3. Mr. Khorshed Alom , District Programme Manager,NHM, praise all SDM& HO,BPM's, ABPM's for the good performance in World Population Day & Fortnight and requested to all to maintained the client exit interview and improve the standard of quality care.
4. From the discussion with the official from Block Level it has come to light that training program in Family planning permanent and temporary method in the District is urgently needed and the board requested to all BPM's to submit the status report to District Family Planning Coordinator of non trained person from their respective BPHC,SC,SD,MPHC etc.
5. From the discussion with the officials, the board feels that the NSV camps were fails only because of lack of proper survey and awareness and the MPW's are not active and cooperative specially in NSV cases and without them the ASHA are facing problems to convince people. Therefore, it is the duty of all to create awareness. The board advised for arranging some awareness programme in these areas where local resource persons should be used for easy communication with the community and instructed to all BPM's to engage MPW's.
6. Dr. NM Das, Joint Director, District Health Society, Goalpara discussed about the Death Case happened in Lakhipur BPHC during World Population Day & Fortnight and all failure cases. He said that all failure, complication and death cases (if happen) will reviewed in quarterly basis under District Family Planning Indemnity Subcommittee and instructed to all SDM&HO, BPM's & ABPM, s to review all cases and performances in their monthly meeting and send the cases in proper format along with all necessary documents to Additional Chief Medical & Health Officer (FW) Goalpara.

The following action plan was decided in the Meeting:

1. Capacity building of DQAU and DQT.
2. Greater clarity on the status of NSV cases & its performance in the district.
3. Identify the issues and challenges that act as bottlenecks in the proper implementation of the Family Planning Services.

The meeting ended with sharing of compliments between the board and the participants present in the meeting. All the employees from National Health Mission present in the meeting and other sectors from Government of Assam, with a mutual commitment to ensure the implementation of all the above mentioned decisions within the time frame.
