The meeting started with welcome address by the Deputy Commissioner, Karimganj.

After discussion, the following decisions have been taken:

1. The committee is appraised about the PF performance for the year 2017-18 up to February'2018. During discussion, it came to light that although female sterilization & PPIUCD have increased from the previous year, the IUCD insertion have come down. After analysis, it has been observed that in some cases due to missing of thread, a negative message spread out in the area which hampered and lowered the performance.

The committee decided that in case of reported missing thread or complications, the cases be treated at the BPHCs as far as possible and then be referred to the DH.

2. The committee is informed about the activities under the Mission Parivar Vikas programme like MPV campaign, introduction of new contraceptives and oral pill, conducting Saas Bahu Sammelan at the SC. It has been informed that for new contraceptive, district level training have been conducted,trainees were from blocks & sectors. The necessary fund have been released to the BPHCs & Sectors and the sectoral training will be completed by 31st of March and are requested to introduce the injectable programme at the BPHCs and sectors.

3. The committee has been informed that although Dr. A K Biswas has undergone training on Laparoscopic Sterilisation, but he is not attending LS camps due to lack of confidence as expressed by Dr. A.K.Biswas himself and only Dr. S N Paul is conducting LS camps alone. To share the burden of LS camps, the committee decided that Dr. A K.Biswas be requested to attend a few camps along with Dr, S N Paul and thereafter to attend camps independently.

4. The committee is informed about the status of various trainings and it is decided that due to paucity of time, the trainings which could not be completed by 31st March, be completed by 1st Week of April.

The meeting ended with a vote of thanks from the chair.
