- 4) Review of Family Planning Performance: The committee reviewed the FP Performance for previous year and the current year. The committee is appraised about the review of the State /ELA and current performance.
- 5) Trainings: The committee has been informed about the status of various trainings conducted in the year 2016-17. The committee advised to complete the trainings within March'2017.
