

1. Discussion on Sterilization Failure Claims: The committee discussed about the failure claims. One failure claim viz. Ayesha Khatun was rejected as she got her claim earlier. Three other cases have been scrutinized and the committee advised to submit the claims to higher authorities.
2. Review of Family Planning Performance: A comparative study of the family planning services have been produced before the committee and the committee after discussion expressed satisfaction for improved performance including MPV fortnight except performance of PPIUCD. The committee has been appraised about the recent notice to trained service provider for PPIUCD. It also requested the doctors of civil hospital to expedite PPIUCD Insertions and Dr. A.K.Biswas is requested specifically to look into the performance and request all to improve their individual performance. The committee also requested to clear the compensations/incentives of PPIUCD immediately after insertion.
3. Training of LS and NSV Surgeon : The committee is concerned about the absence of NSV surgeon in the district and hence it proposed the names of Dr.Tasdiq Alom, Dr. Baharul Islam and Dr. Lipi Deb and request the state to give all or any of them for NSV Training as early as possible. For Lap Sterilization Dr. A M Tapadar may be reoriented and Dr. Santanu Das is proposed for new Lap Sterilization training. As it has been brought to the notice of the committee that for PPS a special training is required so the name of Dr. A K Biswas is proposed for PPS training.
4. Misc: As IRCS is providing family planning services, the committee decided that FP compensation and incentives be passed on to beneficiaries. The committee also decided to request the higher authorities to provide two sets of new Laparoscopes along with all other accessories.


The meeting ended with a vote of thanks from the chair.
