District Quality Assurance Committee O/o the JT Director of Health Services Date- 6/01/2017 Minutes of the meeting.

The meeting was presided over by JT DHS Lakhimpur, Participants were SDM&HO, all BPHCs, superintendent NLCH, Gynecologist, Surgeon and advocate as DQAC Lakhimpur members.

The decisions taken were-

- 1. The Jt. DHS Lakhimpur told that Quality should be maintained to reach goal of IMR, MMR and TFR and it should be maintained by all Health Institution.
- 2. The DFPC, NHM spoke that dignity aspect should be emphasized while delivering service at institution and BPHCs should remember this aspects while conducting camps.
- 3. The SDM&HOs of BPHCS told that Increasing in the number of failure cases of Family planning services is a concerning subject of District Health society. So, enlisting of beneficiary prior to the service delivery should be done so that laboratory test, pregnancy test etc can be done in better way.
- 4. The JT DHS, Lakhimpur told that at SC level ANM should given importance on IUCD insertion along with distribution of OP &CC, the BPMU has to identify and enlist the untrained ANM for IUCD and submit the names to district for upcoming training.
- 5. Dr. M.M.Borua, Empanelled LS surgeon of North Lakhimpur told that Eligible couple Register should be updated in regular basis and the proper monitored should be done at BPHCs.
- 6. The DPM Lakhimpur emphasized on regular payment of ASHA incentive in the BPHC. The DCM, Lakhimpur was instructed to analyze the incentive received by ASHAs.
- 7. The DPM Lakhimpur also briefed on the NQAS process in the North Lakhimpur Civil Hospital which has been already started and he emphasized on separate meeting of the DQAC for review of NQAS progress in NLCH which is to be done through the DQT notified.
