1. Addl. Chief Medical & Health Officer (FW), Lakhimpur explains the terms and reference of the District level Indemnity Sub-Committee (DISC) in the district level.
2. The issue of failure of female sterilization was discussed in respect of Quality. It was discussed that ectopic pregnancy can be considered as failure of sterilization.
3. The convener instructed for required documents to be submitted for failure of sterilization. The documents were as follow-
  - Application Claim form
  - Consent form with Laboratory Certificate
  - Discharge Certificate
  - Sterilization Certificate
  - Proof of failure (MTP certificate/Birth certificate/Ultrasound report)
  - Photocopy of Bank account pass Book.
4. Addl. Chief Medical & Health Officer (FW), Lakhimpur stated that in 2015-16 five (5) numbers of Sterilization failure cases are submitted but only 3 nos. of cases are selected for payment. The selected cases are still not paid.
5. Addl. Chief Medical & Health Officer (FW), Lakhimpur further instructed to ensure that the submitted documents in the district level will be properly audited and forwarded to state Head Quarter.

The meeting ends with a vote of thanks from Jt. Director of Health services, Lakhimpur.
