Sir,

With reference to the subject cited above, I would like to inform you that, National Health Mission, Assam had invited bids for procurement of 752 Laptops and 524 Desktop Computers through GeM, vide Bid Ref No: GEM/2018/B/24130 and GEM/2018/B/28988 respectively. Accordingly order was placed to M/s WEBNET ASIA (L1 bidder) for supply of Laptops and M/s LATEST DEVICES PRIVATE LIMITED for supply of Desktop Computers. But, Acer

India (Pvt.) Ltd., OEM of the product quoted by the L1 bidders of both the products, vide letter under reference informed that, M/s WEBNET Asia, M/s LATEST DEVICES PRIVATE LIMITED and M/s Balaji Enterprises are not authorized channel partner of Acer to sell any product in GeM and they are unauthorized and not genuine supplier. It is also mentioned that, Acer will not take any responsibility of warranty and after-sale-services of the products supplied by the bidders. The matter was intimated to you earlier vide letter under reference.

The matter was communicated with the concerned vendors to clarify the matter and submit valid authorization certificates from the OEM.

But, both the vendors namely M/s WEBNET Asia and M/s LATEST DEVICES PRIVATE LIMITED failed to submit valid authorization certificate from the OEM.

It is decided to cancel the both the orders and both the bidders M/s WEBNET Asia and M/s LATEST DEVICES PRIVATE LIMITED are declared disqualified to participate in any tender under National Health Mission, Assam for a period of 5 years from the issue of this order.

You are requested to do the needful to **cancel the orders in GeM Portal** and also **make necessary arrangement to deposit the earnest money to the State Health Society account.**
