The welcome address was given by Jt. DHS- Dr. (Mrs.) Kareng Rongpipi and the main objective of the meeting was also briefed by Addl. CM&HO- Dr. (Mrs) Tanuja Borah.

Points of Discussion:

1. Fixed Day Services at Diphu Civil Hospital.
2. Fixed Day Static health institution in the district.
3. Area wise FP reporting.
4. Local language translation of sterilization consent form, medical record checklist, sterilization certificate and post operative instruction card.
5. Model Hospital Kheroni.
6. Trained service provider empanelment.

Resolutions:

1. Every Saturday Fixed Day Services for sterilization will be done at Diphu Civil Hospital. As there is no functional OT in other health institution in the district.
2. Fixed Day Static Services will be done only at Diphu Civil Hospital where service provider for sterilization is posted and OT is functional in the district.
3. Family Planning reporting will be made on service delivery (facility based reporting)
4. Sterilization consent form, medical record checklist, sterilization certificate and post operative instruction will be printed in the local language.
5. Fixed Day Services at Kheroni Model Hospital will be done after functioning OT certificate issued by the concerned health institution.
