Minutes of the District Indemnity Sub- Committee (DISC) Meeting



The meeting was chaired by Dr. Altaf Ahmed, Joint Director of Health services, Tinsukia and the following points were discussed during the meeting.

- Dr. Altaf Ahmed, Joint Director of Health services, Tinsukia in his inaugural speech gave a brief and concrete overview of District Quality Assurance Committee (DQAC) and Dist Family Planning Sub-Committee (DISC).
- Joint Director of Health services, Tinsukia suggested that all the doctors are mandatory to be in the empanelled list of DQAC and DISC those who are performing Minilap, PPS/ Tubectomy, MTP etc.
- Updating of Empanelled surgeon will be done by Joint Director of Health services, Tinsukia and accordingly a notification will be issued.
- On his speech, Dr Ahmed appealed to the members, that after operation if any complication and failure occurs, they should guide the beneficiary well and inform them about their rights through the family planning indemnity scheme (FPIS).
- It is to be ensured for avoiding complications during sterilization, emphasis should be given for the quality of services. So, a resolution was taken to make proper action or steps to collect before holding the fixed day and fixed day static services.

- Ensured for random checking of Annexure – 19 (Client Exit Interview) during Fixed day services and fixed day static site.
- Because of summer season and WPD fortnight which is going to be observed in the next month where the fixed day services in different venues of Tinsukia Dist will be organized by DHS, Tinsukia. So the facility should have adequate arrangement of storage and supply for safe and pure drinking water in all the designated health facilities for sterilization. Moreover, the facility should ensure adequate power backup in all the patient care areas as per load.
- An overview of total performance, failure, complications, death and claims has been discussed by the Chairman of the meeting.
- Chairman has also requested the surgeon to attend the fixed day services on time as scheduled.


The meeting was ended with vote of thanks from the chair.
