The following points were discussed and decisions were taken as follows:

1. For strengthen , quality maintain and focus on family planning performances, a ~~district~~ level review meeting will be held on this month of last where block level officials, MOs, ANMs and ASHAs will represent the same.
2. The House decided to reconstitute the District Quality Assurance Committee under the chairmanship of Deputy Commissioner, Dhemaji.
3. The House decided to draft a letter to all BPHC In-charges to take particular review meeting quarterly on Family Planning activities with service providers and other workers for strengthen the FP services.
4. The house decided to draft a letter to MD, NHM, Assam for required a Laparoscopic sterilization training for two new surgeons i.e. Dr. Mohan Narah from Silapathar Model Hospital & Dr. Jyotish Doley from Jonai CHC.
5. Condom boxes will be made available in all Health Institutions including sub-centres of Dhemaji district. In this regard, a tender will be call or otherwise the work order will be give to the regular party i.e. M/S Dhemaji Offset printers which was already supplied 35 nos. condom boxes in last F.Y. 2017-18.
6. The house decided to take over the new LS machine (2 nos.) which was send by State NHM office to Dhemaji Civil hospital and will be supplied to Jonai CHC & Silapathar Model Hospital after got LS trained from this institutes.
