- The meeting also approved the proposal submitted by Shri Ananta Gogoi, DEMO against empanelment of PPIUCD service provider.
- Dr Hemanta Kumar Baruah, Sivasagar give a brief about the inspection of the DQAC Committee to Doomordolong TE Hospital, Khumtai TE Hospital and Demow Model Hospital and found that the operation room in Doomordolong TE Hospital is under renovation so sterilization cannot be done and other institutions are functioning properly.
- The Deputy Commissioner, Sivasagar enquired about the acceptance rate of Family Planning methods amongst the minority populace suggested to organize the awareness meeting at community level (specially minority areas and Tea garden areas). He further informed the house about his forthcoming visit to the Demow Model Hospital very shortly.
- The Deputy Commissioner wanted to know about the failure of the Laparoscope sterilization. Dr. Lalit Ch. Bora explained about some of the major causes of the LS failure.
