Resolution I.

One claim under FPIS for failure of Laparoscopic starilization was subimttered to the State Head quarter. DFPC is directed to take up the issue to the higher authority.

Resolution II

FDS of Laparoscopic starilization at Kusmtala Model Hospital will be possible after full functionalization of OT.

Resolution III

FDS of Laparoscopic starilization at Biswanath Chariali SDCH will be continue as before (in main OT),till the decision is taken by the Joint DHS about the unused EYE OT.

Resolution IV

Early Payment for Family Planning services (beneficieries, Surgeon and others) to be ensured. The SDM&HOs of all BPHC, Suprintendent of District Hospital and The Medical Suprintendent of Tezpur Medical College & Hospital will be communicated.

Emphasis is to be given Post Services Councelling and follow up of the cases through ASHA ASHA Supervisor and ANM.
