Minutes of the District Quality Assurance Committee (DQAC) Meeting

The meeting was chaired by Dr. Altaf Ahmed, Joint Director of Health services, Tinsukia. The following points were discussed during these meeting.

- The frequency of District Quality Assurance Committee (DQAC) and the importance of this meeting have been discussed. The meeting has to be conducted in the quarterly basis on the performance of the surgeon and to deal with the death, failure, complication cases to help reducing risks.
- Joint Director of Health services, Tinsukia has discussed on the procedure for claiming of complication, failure and death cases relating to FP sterilization services.
- Joint Director of Health services, Tinsukia has asked to distribute the Manual of Family Planning Indemnity Scheme guidelines to each BPHC once more and the empanelled surgeon.
- He explained elaborately about the precautions to be taken by the Doctors for the empanelled list and Health Institutions while sterilization operation to be made. Again he emphasized that for quality of service in each health institutions during camp nos. of cases between 35 – 40 and not more than that.
- An overview of total performance, failure, complications, death and claim has been discussed by the Joint Director of Health services, Tinsukia.

- After discussions with all the matters it was come to the conclusion that till date no failure, complications and death cases has been reported from all BPHC under Tinsukia Dist.
- Joint Director of Health services, Tinsukia has requested the surgeon to attend the camp on time as scheduled by the Addl. C.M. & H.O. (FW), Tinsukia.
- The meeting was ended with vote of thanks by DPM, NHM, Tinsukia.
