Sir,

With reference to the above purchase order (at pt. 2 above), this is to inform you that NHM, Assam had awarded to your firm to supply Glucometer and GlucoStrips against the above referred tender and rate contract agreement (Agreement No: 21 AA 249602 date: 30/08/2018).

Your firm has failed in executing both the above orders and the consequences of non-performance already communicated to you through the above mentioned two nos. of Notices, thereby offering adequate opportunity to supply the items. There is no positive response from your end except the only letter dated:-06/06/2019 stating your inability to supply the items.

In view of above negligence and irresponsibility and in line with the tender sub-clause E under Clause 16 (point 2) your firm i.e. M/s Alliance Scientific is hereby debarred from tender of NHM, Assam for the product Glucometer and GlucoStrips for a period five years in addition to forfeiture of Security Deposit and other penal actions. The debarment will come into effect from the date of issuing the letter. Also your current Rate Contract Agreement No: 21 AA 249602 date: 30/08/2018 for supply of Glucometer and GlucoStrips with NHM, Assam is here by cancelled.
