- 2) The Chairman also reviewed the Non Scalpel Vasectomy month performance 2019-20. He instructed the DFPC-NHM that even if the total NSV target is not been achieved during the NSV fortnight but the Male Sterilization should be continued with the help of adjoining district NSV surgeon.
- 3) The Chairman instructed DFPC-NHM to give a NSV SURGEON trg requirement to SHQ-NHM from our district.
- 4) During discussion one query was put forth by Dr. Gautam Das, Gynecologist that can the client claim the DFPISC-Death/Failure Compensation if it occurs during the Post Partum Sterilization performed after the caesarean section which to be clarified from the SHQ-NHM .
- 5) The House instructed the DFPC-NHM that all the claims of Sterilization Death/Failure/Complication should be with all the proper documents as per guidelines to be collected from BPHC level.
- 6) All House also decided to empanel the IUCD/PPIUCD/ANTARA trained manpower of 2019-20.

The meeting ended with vote of thanks from the chair.
