MINUTES OF DISTRICT QUALITY ASSURANCE COMMITTEE MEETING CUM DISTRICT FAMILY PLANNING INDENITY SUB-COMMITEE

Venue: DC Office Conference Hall, Silchar

Date: 29/06/2019

The District Quality Assurance Committee Meeting was held on 29/06/2019 in the Conference Hall, DC Office Cachar, under the chairperson of Smt. Laya Madduri, IAS, Deputy Commissioner, Cachar in presence of the other members (annexure enclosed).

At the outset, Deputy Commissioner welcomed the house. Jt. Director of Health Services explained the objectives of the meeting. A threadbare discussion was held on the quality aspect of the health service delivery with special reference to family planning and following resolutions were taken:

- 1. The Chairperson has emphasized on maintaining up to the mark standard in OT and wards during the LS Surgery and NSV Surgery. Proper hygiene should be maintained. There should be provision of bathroom/ toilet for the beneficiaries in all Fixed Day Sterilization / Fixed Day Sterilization Static Sterilization where FP sercices would be provided.
- 2. Under no circumstances, patient safety should be compromised. Pre-operative check-ups/investigation should be ensured by a medical officer. The SDM&HO/ MO, i/c of the hospital should be responsible for maintaining all necessary formalities. The pre-requisite form must be filled up by Nurses under the guidance of a MO.
- 3. There should be provision of sufficient beds for the FP acceptors and acceptors should be kept at the hospital for sufficient time once they are operated, to avoid any further complication if arises. The camp arrangement fund is to be utilized by all BPHC to ensure all pre requisites (logistic arrangement like Mattress & Drinking Water facility etc.) as per Quality Assurance guidelines. The acceptors must be asked to attend the camp in empty stomach as suggested by LS surgeon during meeting.
- 4. Proper illumination and power supply of power along with extension board with sufficient cables should be ensured in the Fixed Day Sterilization / Fixed Day Sterilization Static Sterilization.
- 5. The house has agreed empanelment of the private hospitals viz; Sibasundari Nari Sikshashram Maternity Hospital. Burrows Memorial Christian Hospital & Emmanuel Rural Hospital on the condition that they fulfill the entire essential criterion. The MD,NHM Assam is requested to approve the proposal of DQAC for empanelment of private health establishment for Family Planning.
- 6. The house has decided to impart training on Semen Analysis to 9 nos.Lab Technicians (from BPHCs and DH) at SMCH to smooth arrangement of NSV.The DFPC will collect the list and will send the nominated LTs at Pathology Deptt.SMCH to undergo three(3) days in service training at SMCH. No TA/DA will be entailed for this purpose.
- 7. The House approved the Family Planning Indemnity claim of LS failure case namely Hasna Begum Barbhuiya as medical verification has been done by technical team and decided to forward the same to the state authority for approval.
