

At the very outset, proceeding of the last meeting was read out and after threadbare discussion, the following decisions were taken:-

- i) Service standards of laparoscopic sterilization shall be improved. The matter to be followed up by the O/o Additional CM&HO(FW), Cachar.
- ii) Preoperative check up shall be conducted thoroughly by the concerned Doctors where FP FDS services will be arranged.
- iii) Air condition facility shall be provided to every facility providing laparoscopic services.
- iv) Semen analysis shall be started urgently. In this regard the Additional CM&HO(FW) Cachar shall nominate one Laboratory technician from each BPHC and one from the District Hospital and communicate with Superintendent SMCH for conducting training within 20/10/19. DFPC will have to ensure the same as directed by Addl. Deputy Commissioner (Health), Cachar.
- v) Addl. Deputy Commissioner (Health) instructed that the Statistical Investigator of Additional CM&HO(FW) Office, must work in coordination with DFPC and maintain proper data. The SI(FW) and DFPC will analysis the FP data every month and will appraise Addl. CM&HO(FW), Cachar.
- vi) For NSV Training, one Doctor from each BPHC shall be nominated by DFPC & Additional CM&HO(FW), Cachar.
- vii) Fumigation of Labour room of all Hospitals shall be done on regular basis to avoid infection. Fumigation of UPHC shall also be done before starting of delivery service.
- viii) The Labour room & OT of Kalain CHC must be maintained properly as stressed by DQAC.

The meeting ended with a vote of thanks from the Chair.
