Sub: - Product debarment notice for non-execution of supply of ordered essential lifesaving drug Injection Pegylated interferon alfa 2b 100 mcg.

Sir,

This is to inform you that NHM, Assam gave you enough opportunity to complete the supply for essential lifesaving drug i.e "Injection Pegylated interferon alfa 2b 100 mcg" for Govt. Health facilities (Medical Colleges) of the state of Assam where patients come with particular ailments to take the treatment and when you have failed to supply the said item, NHM, Assam has served 1st show cause on 24/10/2019 NHM, Assam. Simultaneously, you were served final show cause on 18/2/2020 when it was observed that you did not commence any supply out of supply orders (under reference at pt. no. 1 above).

Please be noted that as per your request letter (under reference at Pt. 2 above), NHM modified the company address so as to arrange necessary supply.

As your such negligence to complete the supply of essential lifesaving drug i.e "Injection Pegylated interferon alfa 2b 100 mcg" which is anti-neoplastic/antiviral drugs directly affecting public health service in the state of Assam and patients are not getting this lifesaving drug, which also hampered the Govt. programme "NHM Free Drug Service" in Govt. Hospitals. It has also enhanced the out of pocket expenditure of the patients.

Moreover, you have not yet submitted performance security against the above mentioned purchase order even after sending you the letter on 29/3/2019 (under reference above at Pt. no.3), which is also a violation of terms & conditions of supply orders as well as tender.

In view of above negligence & in line with the penalty Clause No. 16 "Supply Condition"-Pt. No. I-iii "DELIVERY OF PRODUCTS" of the said tender, your firm i.e Cadila Health Care Limited is hereby <u>debarred</u> from tender of NHM, Assam for the particular drug Injection Pegylated interferon alfa 2b 100 mcg for a period of one year from the date of issuing the letter.

As you have not submitted any performance security for the supply of the said product, hence under the financial penalty, the same amount to be recovered by forfeiting your performance will be not possible in this case. So the same cost will be recovered from any of the outstanding bill of your company and differential amount for procuring the same drug from any other source will also be recovered from any of the outstanding bill of Cadila Health Care Limited.
