Sir,

This is to inform you that with reference to the above purchase order (referred above at pt. 3) that NHM, Assam have awarded to your firm to supply essential drugs against the rate contract agreement (referred above at pt. 2) that you have entered with NHM, Assam for timely supply of items against the L-1 rate quoted by you in the tender (referred above at pt. 1).

Whereas, you didn't complete the supply with in stipulated time which was awarded to your firm on 20/2/18, which is directly affecting the patient community & depriving Public health service in the state of Assam due to non-availability of all such essential items in the Govt. health facilities and also increases the out of pocket expenditure.

Several reminders were mailed to you and even show cause notices were also served to your firm & final time schedule were given to your firm (referred above at pt. 4) but your firm yet to complete the supply which reflects your absolute negligence towards patient health.

In view of above negligence in line with the penalty Clause No. 16 "Supply Condition"- Pt. No. I-iii "DELIVERY OF PRODUCTS" of the said tender (referred above at pt. 1), your firm i.e Dffodils Pharmaceutical Ltd is hereby debarred from tender of NHM, Assam for the products (i) Meropenem 1 gm Injection (ii) Fusidic acid Cream 2% for a period of one year from the date of issuing the letter. Also your current Rate Contract with NHM, Assam (referred above at pt. 1) is here by cancelled.


