- ❖ The discussion of the DISC meeting start with Family planning performance during the FY 2022-23 till Mid of Nov'22.
- ❖ The panel focused on MTP services of the district in presence of the coordinator of IPAS. Dice observed the performance of PAIUCD against MTP as overall performance of PAIUCD is only 9% for the district.
- ❖ It has also observed during the meeting that in few health institution performance of MTP higher than delivery conducted in the hospital. DISC suggested to concerned officials to take necessary step for such HI. Panel also suggested to trained master ToT for CAC from the district so that district can trained service provider on CAC in the district.
- ❖ During the meeting dice discussed on reporting status on provided post abortion/MTP contraception as against MTP provided post abortion/MTP contraception is poor.
- ❖ Observation Family Planning Drive cum NSV fortnight has been discussed during meeting. Dice suggested to plan accordingly to achieve the ELA provided from State Cell for Family Planning Drive cum NSV fortnight.
- ❖ Incentives for service provider for FP services also discussed during the meeting and the DISC suggest to instruct all concerned officials to pay the incentives of service provider so that they may motivate perform continuously.
- ❖ The panel also discussed on follow up the continuation of MPA Injectable doses as the there is a gap in between 1<sup>st</sup> does & 4<sup>th</sup> dose.
- ❖ The DISC also discussed about the Family Planning training for the F.Y. 2022-23 and suggest to conducting the same with in stipulated time.
