

The convenor (Joint Director cum Member Secretary, DHS, Charaideo) of the committee enthusiastically greeted and welcomed all the members presents in the DISC meeting and Add. CM & HO, Charaideo has briefed the objectives of the meeting.

- ❖ The discussion of the DISC meeting start with Family planning performance during the FY 2022-23 till Mid of February '23.
- ❖ The panel focused on the difference in between doses of MPA injectable , as comparing to 1st dose performance of other doses is very low. The DISC suggests the concerned officials to analyze the reason for not continuing the doses. The dice also suggest creating mass awareness under such Health Institute including SC for continuing the MPA doses.
- ❖ The panel focused on MTP services of the district as PAIUCD performance still a challenge for the district, the performance of PAIUCD against MTP is only 7% for the district. DISC suggested to analyze the reason for poor performance of PAIUCD. Further DISC suggests to conduct a meeting with the MO & Staff where MTP has been conducted.
- ❖ Observation of 4th MPV fortnight has been discussed during the meeting. Dice advised to focus on MPA and NSV as performance of both indicators not up to the mark for the District. Further the DISC suggested to plan accordingly to achieve the ELA provided from State Family Planning Cell.
- ❖ Incentives for service provider & beneficiaries for FP services also discussed during the meeting and the DISC suggested to instruct all concerned officials to pay all incentives of service provider and beneficiaries within the FY 2022-23.
- ❖ The DISC also discussed about the Family Planning training for the F.Y. 2022-23 and suggest to conducting the same with in stipulated time.
