Sir,

With reference to the subject above, it is to acknowledge the receipt of your letter dated: 02/09/2020, with your confirmation against non acceptance of the above referred LOA and your inability to execute the Health Materials Transportation Service. In this regard with reference to the earlier NHM Warning letter dt: 24/08/2020, and your subsequent reply stating the inability of your firm to carry out the transportation service is affecting the service of the entire health system for transportation of various health related and essential materials during this COVID-19 pandemic .Your participation in the bidding process, being selected as the lowest vendor and there after your non acceptance of the offer has resulted in significant wastage of time and delay in commencing the service during this COVID-19 pandemic, which is not at all acceptable.

As such, as per the following tender clauses, your firm is hereby debarred to participate in any of the NHM Assam Tender for next 5 years from the date of debarment. Also the Earnest Money Deposit submitted by your firm amounting to Rs.1.00 Lakh will be forfeited.

1. As per tender Clause 3.3.5,

"The most preferred (L1) bidder in the financial evaluation shall be issued the Letter of Award by the TIA inviting for signing the contract. The L1 bidder shall have to deposit the performance security of the prescribed amount and manner within 10 days of issue of the

LoA or signing of the Contract, whichever is earlier. In case the L1 bidder fails to submit the performance Security of requisite amount in the manner prescribed within due date then the TIA reserves the right to forfeit the EMD and debar the defaulting agency from participating in any bid issued by TIA for next 5 years from the date of debarment."

- 2. As per Tender Clause 3.6." Annulment of Award, Forfeiture of Security Deposit & Fresh Award:" and sub Clause 3.6.1:

"Failure of the successful bidder to comply with the requirements of signing of agreement and / or submission of performance security within the time schedule as stipulated above shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security/EMD. Under such a situation, the proposal may be reviewed for award of the contract on the next lowest evaluated technically qualified bidder or go for a fresh bid depending on the circumstance. In case it is decided to go for the next lowest bidder, negotiation may be considered to bring down their price nearer to the originally evaluated lowest bidder."
