This is to inform you that with reference to the above purchase order (referred above at pt. 2) that NHM, Assam have awarded to your firm to supply essential drug i.e Tab Paracetamol 500 mg IP against the letter of acceptance of your firm vide letter (referred above at pt. 3).

Whereas, you have submitted your inability to complete the supply vide letter (referred above at pt. 3) directly affecting patient health and also shortage of basic drug like paracetamol in the peripheral hospitals depriving public health service in the state of Assam.

Final show cause was served vide letter (referred above at pt. 5) to you, whereas the reply received vide letter (referred above at pt. 6) from your end against the show cause notice was not satisfactory &

also not in line with the said tender clause.

In view of above negligence in line with the Tender Clause No. "5", & Pt. No. '5' of the said tender (referred above at pt. 1), your firm i.e M/S VIKRANAT LIFE SCIENCES (P) LTD is hereby debarred from tender of NHM, Assam for the product Tablet Paracetamol 500 mg IP for a period one year from the date of issuing the letter.
