Apart from the ~~resolution~~ ^{meeting} of the committee the following points were also discussed critically and the decisions were taken :

1. The house decided to plan and prepare a NSV (Male Sterilization) beneficiary linelisting format for ASHA/MPW/ABPM for increasing the male participation in sterilization services in Dhemaji district.
2. As per discussion it is find out that the injectable contraceptives follwup performances isn't satisfactory in the district. Hence, The house decided to visit the HI's by DISC members and find out the solution through interaction with service providers.
3. To increase the follwup performances of Injectable Contraceptives, the counseling activity in Health Institutions including district hospital will be followup. Action will be taken by RMNCH Counselor at district hospital and ANM/GNM at others health institutions.
4. The house decided to instruct to all BPHC to include the topic of PAIUCD and NSV review/discussion as special agenda at next block level review meeting and the action taken report may be share with the committee by BPHC.
5. A review meeting will be conduct regarding FP-LMIS issues with block pharmacists urgently.
6. The fixed day services of Laparoscopic sterilization will be organize at Silapthar Model Hospital and Dhemaji Urban Health Centre before the mid of November 2019.

The Meeting ended with vote of thanks from the chair.
