The Superintendent of Dhubri Civil Hospital is to be informed in advance regarding the Camps Schedule /Duties for his convenience to manage other duty roaster accordingly.
- 5) The DFPC informed the house for improvement of the FP performance the proper arrangement of display boards/hoardings, IEC materials for mass awareness should be throughout the district.
