- 2) In the meeting, the internal assessment score of the health facilities under kayakalp quality initiative were shown as well as the gaps were discussed.
- 3) The fund for quality improvement of the identified health facilities may be released as per ROP 2019-20 approval. The District Quality Consultant is directed to process file.
- 4) The committee members asked to give special importance to those facilities which are identified for NQAS, LaQshya and Kayakalp.
- 5) Rafiqul Islam, DFPC, Dhubri presented a PPT of quarterly performance of Family planning service. In the meeting, it was discussed to gear up the Injectable Contraceptive (Antara Programme)
- 6) It was decided that the camps timing should be maintained properly for better quality services.




