
MINUTES OF DISTRICT QUALITY ASSURANCE COMMITTEE MEETING, D H U B R I

7. The committee decided that from next meeting onwards all concern members as per the guidelines should be included in the committee and a fresh notification will be issued in this regard. Apart from family planning issues, all quality related issues will be discussed in the meeting.

- 5) The Joint Director of Health Services cum Member Secretary, DHS, Dhubri, instructed the DME to initiate to arrange display boards/hoardings, IFC materials for mass awareness regarding fixed day static and other FP services throughout the district.
