The Meeting was presided over by the Addl. Deputy Commissioner (H), Dibrugarh. The Addl. CM & HO (FW) welcomed all the Members in presence of Joint DHS, Dibrugarh and explained about the objective of the meeting i.e to review on sterilization death at Khowng PHC.

After detailed discussion following decisions were taken:

- A committee of two medical officer (Dr.Nabajyoti Gogoi and Dr.Kalpana Deka Saikia has submitted a detailed report of Late Dashmi Chowra which death was occurred during the Laparoscopic Tubal occlusion (LTO) procedure on 25-03-2022 under fixed day static procedure at Khowang BPHC, Dibrugarh.
- SDM& HO,I/c Khowng BPHC urged the BPM,NHM of Khowng BPHC, Dibrugarh to submit all the relevant document of Late Dashmi Chowra for completion of claim process.
- Joint Director ,DHS,Dibrugarh appealed to the all the members and concern person that after operation if any complication and failure occurs , they should guide the beneficiary well and inform them about their rights through the family planning indemnity scheme.
- Updating of Empanelled FP service provider will be done by Joint Director of Health Services, Dibrugargh and accordingly a notification will be issued.

- It is to be ensured for avoiding Complication/Failure/Death during sterilization, emphasis should be given for the quality of services. So, a resolution was taken to make proper action or step to collect before holding the fixed day services and fixed day static services. Ensure for random checking of Annexure-19 during fixed day services and fixed day static services.
- DFPC,NHM,Dibrugarh will coordinate with the BPM,NHM,Khowang,Dibrugarh for completion of claim process.
