#### **District Indemnity Sub Committee Meeting**

A Family planning District Indemnity Sub Committee Meeting was held on 22<sup>nd</sup> March'2021 from 2:00 P.M onwards at Youth Club, Mangaldai under the chairmanship of Addl. Deputy Commissioner (Health), Darrang in presence of Joint Director of Health Services, Addl. CM&HO (FW), LS Surgeon, Dy. DEMO, SI (FW), DPM and DFPC.

As per agenda various issues of Family Planning activities were discussed in the meeting.

### During this meeting following points were discussed:

- 1. DFPC, NHM, Darrang explained briefly the objective and agenda of the meeting.
- 2. In the  $4^{th}$  quarter of 2020-21 no claims (failure, complication etc.) were received at District level.
- 3. Dr. Bhaskar Bora, LS Surgeon explained the gaps found in LS Fixed Day Services at periphery Hospital and requested to authority to close the gap.
- 4. The DPM, NHM, Darrang advice to DFPC to monitor the incentive of ASHA, Beneficiary and Providers, especially in PPIUCD, PAIUCD and Antara programme. She has also said that FP-LMIS should be strengthened at all level from ASHA to District.
- 5. i/c Addl. CM&HO (FW), Darrang requested to the Surgeons to attend the LS & NSV FDS in time so that FDS can be finished before 3 pm.
- 6. Joint Director of Health Services, Darrang adviced to continue the LS & NSV FDS routinely and also adviced to gear up the performance of IUCD and Antara.
- 7. Addl. Deputy Commissioner (Health), Darrang adviced to review the performance of Family Planning with Block level urgently. And he also instructed to achive the target of Family Planning by 31st March' 2021.

- DISC & DQAC Members will monitor the designated FDS site (CHC & Model Hospital) so that gaps can be closed urgently and report to be submitted to the Joint Director of Health Services. (Action-DISC & DQAC Members).
- All the payments (ASHA, Beneficiary and Providers incentive) should be clear in time after submitting their claims. (Action- DFPC).
- FPLMIS will be strengthened at all level from ASHA to District within a short time. In this regard review meeting with Block Pharmacist and BCMs will be conducted at District level. (Action- DDSM & DFPC).
- Surgeons are directed to attend the LS & NSV fixed day services in time and finish the FDS before 3 pm. (Action- LS & NSV Surgeons).
- Maximum nos of LS, NSV & IUCD FDS will be planned in the month of February & March' 2021 to gear up the performance. (Action- Addl. CM&HO (FW) & DFPC).
- The DISC Members and District level Officials should be monitored Block & Periphery level Store periodically and also will verify all the family planning related registers and forms. (Action-DISC members & District level Officials).
- District level Review meeting with Blocks will be held within 15 days to gear up and achieved the target of Family Planning in all methods. (Action- DPM & DFPC).
