- A District Level quality Assurance Committee meeting of Family Planning Service was held Mat under the Chairmanship of Joint Director of Health Services, Charaideo on 20/10/2021 at 2 pm. Addl CM & HO (FW), Charaideo, , Charaideo was also present in the meeting. The meeting was started with a welcome speech by the Joint Director of Health Services, Charaideo

- Addl CM & HO (FW), Charaideo Dr. Amrit Saikia provided a brief objective of Family Planning Quality Assurance Committee Meeting. He advised to follow up and counsel all Sterilized cases on the very next day to know if any danger sign occur.
- Dr. Diganta Chetia, Sr. M & HO, Sonari SDCH explain about the quality service to be provided all beneficiary interested and motivated for Female Sterilization and Male Sterilization. Due to minimum bed capacity it is a big problem to provided bed to all beneficiaries after the sterilization done. He requested Joint DHS to provide some extra bed if possible for sterilization.
- As well as minimum 30 nos beneficiary should be identified per camp due to shortage of Manpower under Charaideo District. New Medical officer should be trained for Female Sterilization and Male Sterilization. Only one surgeon is available at Charaideo District.
- On the other hand two numbers new Health Institution should be selected for Female Sterilization under Patsaku BPHC and at Lakwa Model Hospital so that far flung areas beneficiary can reach the centre easily.
- At the end of the Meeting Joint Director of Health Services suggested all Medical officer to be very practical regarding sterilization as well as counseling is very important at community level before and after the sterilization.
