- 1. The meeting began with the welcome of the participants by Joint Director of Health services and briefing of the main objectives of the meeting by DCM. Chirang.
- 2. In the first agenda the house discussed about the certain issues non acceptance of the many family planning methods like NSV, and Laparoscopic by the community. In this regard the Joint Director instructed the DCM to mobilize the community through ASHAs, ASHA Supervisor and BCM to improve the performance as during the fortnight it was zero for NSV.
- 3. The meeting also discussed and resolved that trained ANM in IUCD to increase the IUCD insertion under their SC which is very low. Further, it was also discussed about the issue of letter to ANM through SDM&HO for increasing the performance IUCD..
- 4. The meeting also discussed about the other family planning methods which need to be increased at the community level through ASHAs like oral pill, Condoms, Antara, Chaya etc. AS the distribution is less in the field level for contraceptic HDC it was also instructed to increase the distribution by ASHAS.
- 5. The meeting also resolved discussed about the failure cases . At this DCM-CHirang told the house that there is no report of failure case in Chirang. At the same Joint Director also instructed in the meeting to take up the PPIUCD and PAIUCD. The Health institution with facilities for MTP was also discussed to increase the PAIUCD.
- 6.. The Joint Director also asked DCM to follow up the family planning activities at the field level through BCMs
- 7. The meeting finally concluded with vote of thanks from DDSM, NHM-Chirang.
