CM&HO (FW), LS Surgeon, Dy. DEMO, SI (FW), DPM and DFPC.

As per agenda various issues of Family Planning activities were discussed.

During this meeting following points were discussed:

1. Joint Director of Health Services, Darrang chaired the meeting and welcomed all the present Officials and Members of District Indemnity Subcommittee.
2. Addl. Chief Medical & Health Officer (FW), Darrang discussed briefly the objective of the meeting and also told the current scenario of the district on family planning programmes.
3. DPM, NHM, Darrang told about the poor performance of Family Planning, especially in permanent method during the COVID period. She has requested to Addl. CM&HO (FW) to issue a letter to Blocks to gear up the performance.
4. DFPC, NHM, Darrang discussed the gaps found in family planning services during monitoring visit to improve the quality services. All Family Planning activities to be monitored routinely by District & Block level Team and issues to be discussed at Monthly meeting to close the gap.
5. The LS Surgeons are asked to maintain COVID protocol in the LS Fixed Day Services. In this regard District Authority has be instructed to Blocks.
6. Resolution of previous meeting was reviewed by Joint Director of Health Services. He asked to all to participate actively in Family Planning programmes to gear up the performance both permanent and temporary method.


